With the latest innovation approaches, the OERs give trainers and smallholders new content to upskill both their food production knowledge and entrepreneurship skills.

This up-to-date knowledge will enable smallholders to capitalize on niche market opportunities, secure their businesses, and ultimately grow and succeed.


